Gracious Opulence



Installation

- Install using conventional woodworking techniques including adhesives and/or fasteners.
- Carbide tipped blades are recommended.
- Standard PVC cements or Cellular PVC cements provide a strong bond. Glue all joints to prevent separation.

Finishing

- Sand imperfections in material.
- Wipe with acetone or similar prior to applying PVC primer.
- Fill any gaps and fastener holes with PVC approved caulk or similar prior to applying primer.
- Apply PVC approved primer prior to final topcoat of choice.

Touch Up

- Recommend non solvent based fillers such as all-purpose painter's putty, high performance wood filler or latex caulk.

Storage and Handling

- Store items on a flat surface.
- Keep product free of dirt and debris. If items get dirty use warm water with detergent to clean.
